Please be informed that *March 30-31, 2017* at the National University of Pharmacy (Kharkiv, Ukraine) will be held International scientific and practical conference "**Medications to human. Modern problems pharmacotherapy and prescribing of medications**". The conference is included in the register of congresses, symposia and scientific conferences which will be held in 2017, the registration certificate UkrISTEI number 620 of September 30, 2016.

We invite you to participate in conference. Forms of participation: **publication of abstracts and/or articles** in the following **fields**:

1. Modern problems of pharmacotherapy of human diseases.
2. Study clinical effectiveness of new medicines.
3. Pre-clinical study biologically active substances of a vegetative and synthetic origin.
4. Synthesis, pharmacological activity of new synthetic compounds and vegetable origin.
5. Aspects of teaching biomedical sciences in higher education.
6. Development of technology and medicines based on natural substances and synthetic origin.
7. Search and introduction of new auxiliary substances for developing drugs.
8. Pharmacoeconomic analysis of pharmacotherapy different diseases.

Working languages: Ukrainian, Russian, English.

Proceedings of the conference (abstracts, articles) will be published in "Medications - to human. Modern problems pharmacotherapy and prescribing of medications". The Collection was assigned the International Standard Serial Number (ISSN). **Deadline - February 28, 2017.**

All the authors who have **published abstracts and/or articles** will be sent an **electronic version of a collection of conference materials** in .pdf format. and an **electronic version of the certificate**.

**Requirements to abstracts (Appendix 1):**

- Abstracts are sent in the format MS Word .doc;
- Volume - 1-2 full pages (A4 format);
- Field - top - 2 cm, bottom - 2 cm, left - 2 cm, right - 2 cm;
- Font - Times New Roman;
- Font-size - 15;
- Spacing - a multiplier 1;
- Obligatory structure of theses: introduction, aim of the study, materials and methods, results and conclusions;
- **The name** of the work is in bold, capital letters; on the next line is indicated the **name and initials of the author(s)** with a large lowercase, normal font, centered; below - the **full name of the place of work, city, country** with a large lowercase, normal font, centered;
- Academic titles and academic degrees of the authors are not indicated;
- the use of tables, graphs, charts, and illustrations are NOT allowed;
- list of literature is not indicated.

**Requirements to original article (Appendix 2):**

- Original article are sent in the format MS Word .doc;
- Volume – 5-8 full pages (A4 format);
- Field - top - 2 cm, bottom - 2 cm, left - 2 cm, right - 2 cm;
- Font - Times New Roman;
- The main text font size - 14, tables, figure captions, diagrams and literature list font size – 13;
- Spacing - a multiplier 1;
- Obligatory structure the original article: introduction (the word "introduction" is not written), materials and methods, results and discussion, conclusions and literature;
- **The name** of the work is in bold, capital letters; on the next line is indicated the **name and initials of the author(s)** with a capital letter lowercase, normal font, centered; below - the **full name of the place of work, city, country** with a capital letter lowercase, normal font, centered;
- Academic titles and academic degrees of the authors are not indicated;
- Section titles (except for the introduction and conclusions) are printed with a paragraph in bold. After the partition name on the same line as the main text is printed. The word "conclusions" is printed in the center, with a capital letter in lowercase, regular font. Between the text of the article and conclusions should be an empty string. The word "literature" is printed similarly to "conclusions";
- List of literature - in alphabetical order, first Cyrillic, then Latin. Sources of literature are made in full: authors, title of the article or book, the original data (city, publisher, year), the number of pages for publication in journals and collections -

year, volume (if any), number of the issue or magazine;

- Diagrams and tables in the articles are made in the respective routines in Microsoft Word. All inscriptions and marks directly in the diagrams - font-size 9-10 (font Times New Roman). In the captions of diagrams, figures and totally tables and list of literature font size 13. Figures and diagrams should be in black and white.

**Requirements to review article (Appendix 3):**

- Review article are sent in the format MS Word .doc;  
- Volume – 5-8 full pages (A4 format);  
- Field - top - 2 cm, bottom - 2 cm, left - 2 cm, right - 2 cm;  
- Font - Times New Roman;  
- The main text font size - 14, tables, figure captions, diagrams and literature list font size - 13;

- Spacing - a multiplier 1;  
- Obligatory structure of review article: actuality of the problem, review of the literature with citing sources, conclusions and list of literature;

- **The name** of the work is in bold, capital letters; on the next line is indicated the **name and initials of the author(s)** with a large lowercase, normal font, centered; below - the **full name of the place of work, city, country** with a large lowercase, normal font, centered;

- Academic titles and academic degrees of the authors are not indicated;

- Section titles (except for the introduction) are not printed. The word "conclusions" is printed in the center, with a capital letter in lowercase, regular font. Between the text of the article and conclusions should be an empty string. The word "literature" is printed similarly to "conclusions";

- List of literature - in alphabetical order, first Cyrillic, then Latin. Sources of literature are made in full: authors, title of the article or book, the original data (city, publisher, year), the number of pages for publication in journals and collections - year, volume (if any), number of the issue or magazine;

- Diagrams and tables in the articles are made in the respective routines in Microsoft Word. All inscriptions and marks directly in the diagrams - font-size 9-10 (font Times New Roman). In the captions of diagrams, figures and totally tables and list of literature font size 13. Figures and diagrams should be in black and white.
